Health News

The subject for this article is skin cancer prevention. You may have noticed that past articles from me often deal with health issues I have encountered. I figure if it happens to me, it may also happen to you, as we are all of a "certain age". I go to a dermatologist each year for a skin check and this year I asked about a little scaly patch on my nose. It was diagnosed as actinic keratosis and was dealt with very easily at the office that day. Since I know a lot of my fellow retirees spend time in the sun golfing, boating, gardening or just enjoying the sun, I thought you should be aware of this condition. The following is from the Mayo Clinic website.

An actinic keratosis (ak-TIN-ik ker-uh-TOE-sis) is a rough, scaly patch on your skin that develops from years of exposure to the sun. It's most commonly found on your face, lips, ears, back of your hands, forearms, scalp or neck. Also known as a solar keratosis, an actinic keratosis enlarges slowly and usually causes no signs or symptoms other than a patch or small spot on your skin. These patches take years to develop, usually first appearing in people over 40. A small percentage of actinic keratosis lesions can eventually become skin cancer. You can reduce your risk of actinic keratoses by minimizing your sun exposure and protecting your skin from ultraviolet (UV) rays. Also be sure to use a sunblock of at least 30. The signs and symptoms of an actinic keratosis include: rough, dry or scaly patch of skin, usually less than 1 inch (2.5 centimeters) in diameter, flat to slightly raised patch or bump on the top layer of skin, in some cases, a hard, wartlike surface, color as varied as pink, red or brown, and itching or burning in the affected area Actinic keratoses are found primarily on areas exposed to the sun, such as your face, lips, ears, hands, forearms, scalp and neck. An actinic keratosis is caused by frequent or intense exposure to UV rays, from the sun or from tanning beds.

If treated early, almost all actinic keratoses can be cleared up or removed before they develop into skin cancer. If left untreated, some of these spots may progress to squamous cell carcinoma — a type of cancer that usually isn't life-threatening if detected and treated early.

The awardees are:

Maria Ziaja from City Honors School. Though City Honors does not rank their seniors, Maria's weighted cumulative GPA is 4.7 on a 4.0 scale. She has received a national AP Scholar recognition based on the number of Advanced Placement courses completed, a Regents Diploma with Advanced Designation with Honors, and an International Baccalaureate Diploma. She is also a member of the National Honor Society. For school activities, she participates in Kids Care/Helping Hands Club, Rocket Club and is the team captain for the Varsity Track and Field where she usually participates in the relay races and long jump. Some of her out-of-school activities include being a member of PUSH which is an neighborhood outreach program to educate low income families in renewable resources, the Buffalo Waterkeepers, and volunteering as an assistant in the Teach Arts for Girls program. Maria also takes piano lessons. Being a refugee of the challenges of domestic violence has given Maria a passion for ecology and social justice. She plans to attend Vassar College where she hopes to study Environmental Studies leading to Environmental Law.

Maliha Methila is a student from Frederick Law Olmsted School where she ranks first of 112 seniors with a weighted cumulative average of 99.32. Maliha is a member of the National Honor Society and the school's Creative Writing and Peer tutoring groups. Her diploma will have the NYS Seal of Bi-literacy, which proves bi-literacy. In her community, Maliha participates in a language club, Tae Kwon Do Bangla School, teaching children their home culture and community tutoring volunteers. She has been accepted at the University at Buffalo and her goals are to become a Pharmacist and work with the community providing quality care.

Jevon Whittington will receive the BRTA Scholarship in honor of Josephine Slacer for his perseverance, community awareness, leadership as well as desire to continue education. He is a student at the Buffalo Academy for the Visual and Performing Arts where he is second of 101 seniors with a weighted cumulative average of 92.92. His schools activities include The National Honor Society, Kindness Project, Yearbook Club, African American Quiz Bowl, Senior Board, Band Against Bullying community, and several school musicals. Jevon's out of school activities include ECMEA Jazz Festival, NYSSA School of Choral Studies. He has performed at the State of the State Address and State of the City Address. He was also a youth counselor at the South Buffalo Boys and Girls Club. His awards include the National Academy of Future Scientist and Technologist Award of Excellence, first place winner of the Youth Entrepreneurship Showcase and the lead role is the school musical, "Chicago." Jevon hopes to pursue a career in Physical Therapy.
